Hi Friends!

Your club needs some help to keep it running. Yes, elections are coming up and we have some open positions. Following our new by-laws, the positions we will be voting on are the 1st VP, 2nd VP, Recording and Corresponding Secretaries, Treasurer, and 3 Board Members.

The 1st VP is a two year term. The second year they are the President.

The 2nd VP, Secretaries, and Treasurer are one year positions. The Board members are 3 year positions.

Treasurer

We have been fortunate the last few years having Mike Anderson as the Treasurer. He has unfortunately decided to not accept a nomination for next year. You do not need to be an accountant as we are looking into hiring one. The new Treasurer will be the liaison between the Accountant and the club, paying the bills, depositing the funds from events, and presenting reports from the accountant to the Board.

Nominations are currently open until the beginning of the December General Meeting. You may nominate anyone in good standing, they must accept the nomination. You may also self nominate.

Club Voting – Summary Continued

President

1. Shall have general superintendence and direction of all other officers of VBAC and see that their duties are properly performed.
2. Preside at all meetings of the membership.
3. Appoint all standing and special committees described in Article VIII.
4. Serve as ex-officio member of all committees.
5. Represent VBAC at conferences, symposia and other meetings at which the VBAC is expected to be represented.
6. Prepare the agenda for the Board meeting.

First Vice-President

1. In the event the President is unable to exercise his duties, assume the duties of President as described above.
2. Assist the President in conducting general membership or board meetings.
3. Serve as Membership Coordinator. As such, maintain records to include name, type of membership, address, telephone number(s), e-mail address, boat name and current dues status.
4. Maintain list of member volunteers as submitted by committee chairs, for eligibility for participation in selection of club sponsored tournament teams.
4. Coordinate and solicit nominations for the fall elections.
5. Serve as the VBAC Historian.

Club Voting – Summary Continued

Second Vice-President

1. Assist the President and First Vice-president as instructed.
2. In the event the First Vice-President is unable to exercise his duties, assume the duties of the First Vice-president as described above.
3. Coordinate the activities of standing and special committees as directed by the President.
4. Coordinate and solicit nominations for the fall elections.
5. Serve as the VBAC Historian.

Recording Secretary

1. Attend and maintain a written record of all board and general membership proceedings.
2. Report the minutes at scheduled meetings of the board and membership.
3. Maintain Club documents to include By-Laws, Minutes (keep for seven (7) years), Agenda, etc.
4. Perform other such duties as required by the President or the Board.

Corresponding Secretary

1. Compile, write and publish the VBAC newsletter, Tight Lines, forwarding it to the membership before each scheduled meeting.
2. Coordinate with the First Vice President the records required to forward the newsletter to the membership.
3. In the event the Recording Secretary is unable to exercise assigned duties, assume the duties of Recording Secretary as described above.
4. Assist the officers and board members with the preparation of other correspondence as may be required for the effective administration of the VBAC.

Club Voting – Summary Continued

Corresponding Secretary Continued

5. Maintain an updated Club Roster and make it available to members when requested.

Treasurer

1. Serve as the chief financial officer of the VBAC and provide for the safekeeping and accounting of all VBAC funds. The VBAC funds shall be deposited in an account with a local bank. The President and Treasurer shall be authorized to withdraw funds from this account. The signature of either one of these officers is to be acceptable by the bank. Only one signature is required.

2. Collect and account for all dues, sales and tournament proceeds and such other funds that accrue to the VBAC.

3. Pay accounts payable by check after determining their accuracy and legitimacy.

4. Prepare an annual budget for Board approval by the end of January of each year.

5. The fiscal year shall coincide with the calendar year.

6. Prepare and deliver a written financial report at each board and membership meeting.

7. In coordination with the President, arrange for an audit of the VBAC's accounts at least annually and as otherwise directed.

8. Prepare and file local, state and federal tax returns as required.

9. Act as the VBAC Registered Agent.

10. At no time shall only one member be listed on any financial account that VBAC owns. 11. The financial records of the organization are public information and shall be made available to the membership, board members, and the public.

Club Voting – Summary Continued

Line of Succession

The line of succession shall be President, 1st Vice President, 2nd Vice President, Recording Secretary, Corresponding Secretary, Treasurer, and Board of Directors (year elected to the Board (current term), then years as a VBAC Member).

Board of Directors

A. General Powers The affairs of VBAC shall be managed by its Board of Directors, hereinafter referred to as the BOD. The BOD shall have control of and be responsible for the management of the affairs and property of VBAC.

B. Number, Tenure, Requirements, and Qualifications

1. The BOD shall comprise the six (6) Officers described in Article VII and nine (9) Board members.

2. Board Members will serve three-year terms. The three (3) new members elected each year will replace the three members that have been on the Board for three (3) years.

3. The immediate past President shall serve as the Chairman of the Board of Directors. a) The intent is to provide guidance and history for the BOD. b) This is an honorary non-voting position, unless the BOD is tied. Then the Chairman may make the deciding vote.

4. Shall be a member in good standing.

5. Shall be 18 years of age or older.

We tag black drum, black sea bass, cobia, summer flounder, red drum, sheepshead, spadefish, speckled trout, tautog and grey triggerfish.

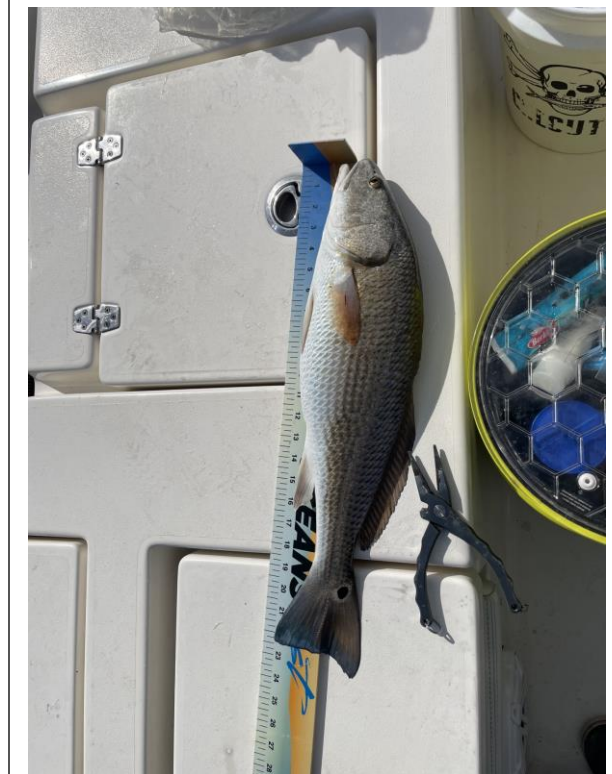


1. The contest will run from January 1 through December 31. All entries from the previous year must be turned in by the regular January business meeting.
2. To be eligible for monthly awards, entries may be mailed to the VBAC Post Office Box, the Prize fish chairperson or placed in the hands of the Prize Fish Committee before the regular business meeting begins, following the month the fish was caught. To be eligible for the annual awards, all entries must be submitted no later than the second meeting following the catch. Catches made in December must be turned in by the following January meeting to be eligible for the previous year's awards.
3. The contest is free and open to all members in good standing whose dues have been paid before the catch, according to the club bylaws. There is no entry fee to participate.
4. The territorial limits for the contest shall be the waters of Virginia and North Carolina and their coasts.
5. To be accepted for entry, fish must be taken on hook and line and must follow all recreational fishing regulations as determined by the state to which it was caught. Only fish caught in waters open to public fishing may be submitted for entry to the Prize Fish Committee.
6. To qualify for entry as a catch, all fish must be weighed on certified scales.
7. In order to qualify for a club record, the fish must be weighed at an official state weigh station.
8. Weights should be converted to pounds and ounces. A witness must be present and must sign the form. If the fish qualifies for a VA or NC state tournament citation, that receipt will meet these requirements.
9. Entries in the monthly contest must meet "minimum club weight requirements" and will be considered for the annual contest. Minimum acceptable weights and lengths are set by the Prize Fish Committee and approved by the Board of Directors.
10. Acceptability of entries will be at the discretion of the Prize Fish Committee whose decision will be final.
11. In the case of a tie in the catch category, length, then girth will be used to determine the winner.

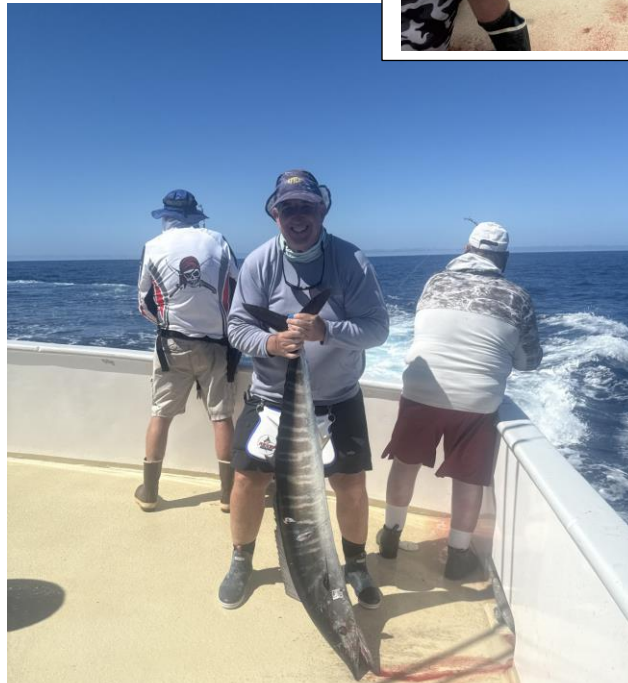

On a beautiful fall morning, October 18th, Rich Califf and I headed to the areas around Lynnhaven to search for some Puppy Drum.

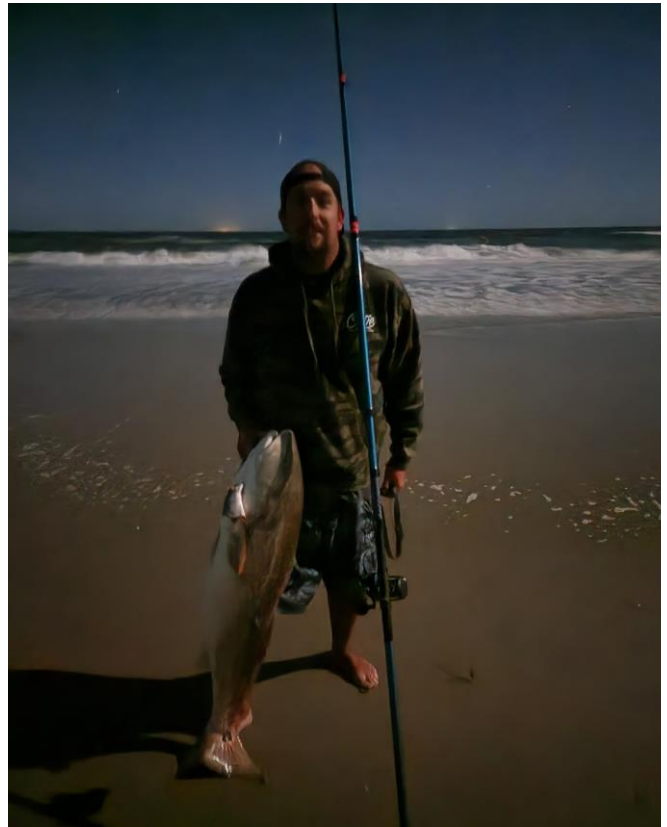

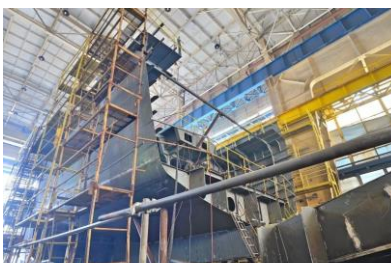

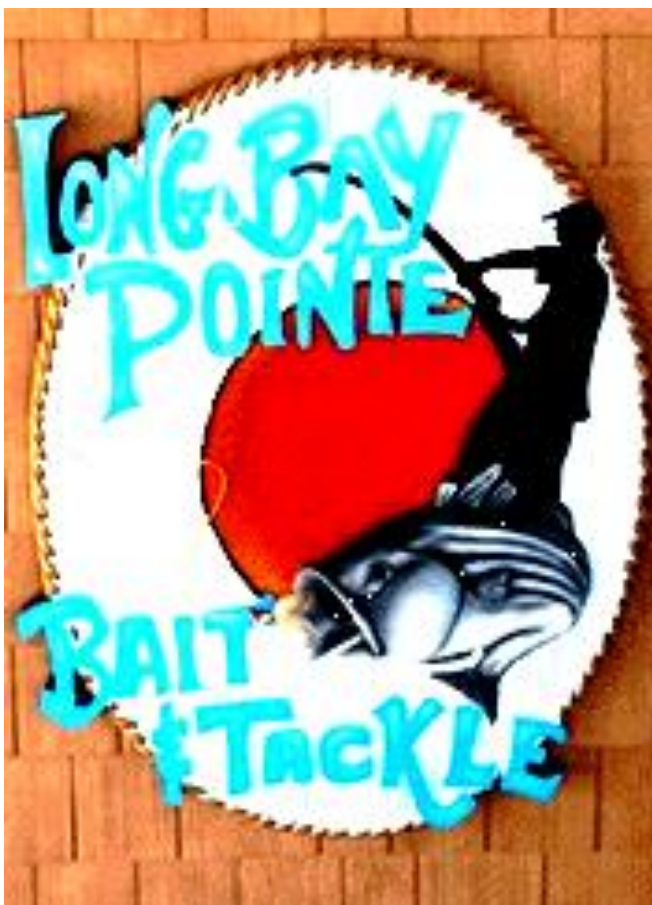
