

VBAC Fish Roulette

Here's how it works– interested club members put \$20 in a pot by the March meeting (Mike Anderson holds the pot). At the March monthly meeting, we will draw the names (species) of five fish from the club's leader board*. These fish will be the targeted species eligible for winning a lucky VBAC angler a share of the pot. The angler with the heaviest catch for the selected species by Dec 31, 2016 will share the pot with the other winners. There is no minimum size limit for the fish; simply that it must be weighed on certified scales. This format will provide an even opportunity for salt, surf, and fresh water anglers, as both fresh and saltwater species are eligible for the drawing. *(Wahoo, Tuna, Gar, and Amberjack will not be part of the drawing)

As a reminder, starting July 1st, 2016; the boater safety certificate requirement is in full effect. That means you must have a boater safety certificate to operate a power driven vessel regardless of your age. There are some seats left in our class that will be held on February 20th. 



COBIA CLASSIC TOURNAMENT RULES AND REGULATIONS

- 1. The deadline for registration is Friday, June 17, 2016 @ 7:30P.M.
- 2. The Virginia Beach Angler's Club reserves the right to refuse entry to any angler or vessel.
- 3. The Entry Fee is \$100.00 per boat if paid by June 11, 2016, thereafter the fee is \$125.00.
- 4. The Tournament Committee advises all participants to attend the Captains meeting to insure they are aware of any rule changes or clarifications.
- 5. At the Captains meeting, the Tournament Committee will decide if Saturday is fishable. If Saturday is declared not fishable, the tournament will be rescheduled for Sunday.
- 6. Each boat entered in the Tournament will be eligible for only one prize.
- 7. The Tournament Committee reserves the right to inspect all boats entered in the competition.
- 8. A boat may not be replaced after the entry deadline, unless broken down. A tournament official must be notified on the change before "lines in."
- 9. All fish must be caught on hook and line.
- 10. Fish shall not be mutilated in any way other than hook and gaff marks.
- 11. Two or more boats congregating close enough to pass fish may be disqualified from the tournament.
- 12. Scales will be open from 3:00P.M. to 5:00 P.M. All fish must be weighed by the official VBAC Tournament Weighmaster.
- 13. All fish must be weighed in at the Tournament Headquarters not later than 5:00P.M.
- 14. Fish will be checked for freshness and are subject to inspection of stomach contents.
- 15. All protests must be submitted no later than 30 minutes after the weighing of the last fish.
- 16. Prizes will be awarded @ 5:30P.M. at Tournament Headquarters, Long Bay Pointe Marina.
- 17. Prizes are awarded solely on the basis of fish weight. In the event of identical weights, the first fish weighed in will be declared the winner.
- 18. Winning anglers may be requested to submit to and successfully pass a polygraph test prior to being presented any prize.
- 19. Boat registrant must be present and positive identification is required for all prizes.
- 20. According to Virginia regulations, no fish less than 37 inches will be weighed.

The following statement must be read, signed and turned in with the entry form.

"I understand that as Tournament Captain, participant, or boat owner, I am responsible for my boat and occupants at all times. I have read and fully understand and agree to abide by the rules of the Virginia Beach Angler's Club Cobia Classic. I hereby release The Virginia Beach Angler's Club, Long Bay Pointe Marina, and their affiliates from any and all liability. I further understand that the decision to fish and participate in the Tournament is the responsibility of the registrant, Captain or boat owner.

Fishing Report – February 20th Crappie Fishing – by Russell Willoughby

Went fishing with Steve Harding on the Northwest River in North Carolina. We caught a nice mess fish together. 32 crappie and yellow perch caught on a warm day. Steve Harding's boat w/ Russell Willoughby.

Fishing Information by Melanie Bayford

Since I have learned the long pole technique for crappie, I have been thinking about an easy way to modify my small boat for that purpose when needed. My boat has four vertical rod holders in the middle part of the boat, two on each side. We had a wore out broom in the garage. The heavy wooden handle fit perfectly into the rod holders. I took the broom handle to the local hardware store and bought four c shaped clamps the size of the handle to attach the broom handle to the board.

I cut the handle off and cut it in half. Measured the board I had to the side of the boat and marked where the handle halves need to be attached. Screwed down the clamps and took it outside. Perfect fit. I had a few of the screw



on rod holders, so I mounted those to the board. I used the long poles and a few surf rods to adjust the rod holders to the correct angle. Now I have something to use for crappie that can be carried in the vehicle and put on after the launch. It took me less than two hours to build with hand tools. Photos are attached. Melanie
